Dear Candidate,

This has reference to B.Sc. Nursing (PB) Entrance Examination that was held in **July, 2022**. In this connection we wish to inform you that, Regional Admission Counseling of IGNOU Regional Centre, Lucknow is scheduled to be held on **28.11.2021 at 09:30 AM at IGNOU Regional Centre, 5-C / INS-1, Sector-5, Vrindavan Yojna, Telibagh, Lucknow.**

**Documents that are required to be submitted / forward by post and by e-mail by the Applicants at the time of Counselling / for the Counselling: (One set of coloured scanned copies / photos / self attested photocopies, to be verified against original):**

**(i). By All Applicants:**

- 1). Original Admit Card for Entrance Test, signed by the Invigilator.
- 2). 10<sup>th</sup> Class or Matriculation or equivalent Certificates.
- 3). 10+2 Class Certificate.
- 4). Valid RNRN Registration Certificate (In case registration is done from more than one council, all such certificates).
- 5). Experience Certificate(s) on Letter Head of the competent authority with full name, date and signature with stamp.
- 6). GNM Diploma Certificate and Marks Sheets for all years.
- 7). NOC from the organization, where the candidate is presently working to ensure the candidate is in service.
- 8). In lieu of mid-wifery, the male nurses must produce certificate in any nursing course of 6-9 months duration as recognized by Indian Nursing Council. The candidates should produce relevant documents authenticating that such nursing course is recognized and approved by the Indian Nursing Council.
- 9). Original Anti-ragging Affidavits in the prescribed formats duly Notarized and signed by Parents and Applicant separately, as given in the Prospectus.
- 10). A Demand Draft of Rs.20,000/- in favour of **IGNOU** and payable at **Lucknow**, towards the **programme fee**.
- 11). The candidates whose documents will be verified online, they have to pay their required admission fees online through the SBI Collect gateway available on the IGNOU website at the following address under the head "Other Fees" - <https://www.onlinesbi.com/sbicollect/icollecthome.htm?corpID=3886367>
- 12). Two Passport size Photographs
- 13). Filled-in Acceptance Form of admission to B.Sc. in Nursing (Post Basic) programme.

**(ii). By Applicants claiming reserved seat:**

- 1). Category (SC/ST) Certificate for claiming SC/ST Seat
- 2). Income Certificate from OBC (Non-Creamy) and EWS Category
- 3). OBC-Non creamy Layer Certificate along with Income Certificate (Not exceeding 8 lakhs) for claiming OBC (Non-creamy Layer) Seat. The Certificate, not older than 3 years, should be in the format as given in the Student Handbook and Prospectus of the Post Basic B.Sc (Nursing) Programme.
- 4). Certificate of Physically Handicapped for claiming PH Category seat, with a minimum of 40% disability, issued by Chief Medical Officer (CMO).
- 5). War-widow Certificate for claiming War Widow Seat
- 6). Kashmiri Migrant Certificate for claiming KM Seat
- 7). EWS as per MHRD, GOI/Indian Nursing Council orders 1-5/2018-INC dt. 09.08.2019.

**(iii). By the Applicants whose name is changed after High School (all documents listed below):**

In case any change in the name (other than the one mentioned in his/her High School Certificate), it is mandatory for the prospective learners to furnish legal evidence of having changed his/her name/surname while submitting the admission form, as given below:

1. Attested copy of the Notification issued in a daily newspaper notifying the change of name.
2. An attested copy of the Affidavit filed before the 1<sup>st</sup> Class Magistrate specifying the change in the name.

3. An attested copy of the Marriage Card/Marriage Certificate in case of women candidates for change in **Surname**.
4. Attested copy of the Gazette Notification reflecting the change of name/ surname.

**Mode of Counseling:**

All the Confirmed and Waiting List candidates from all the categories are being provided with two options for completion of their Admission Counseling:

1. All the candidates of Confirmed and Waiting List, who live in Lucknow and nearby districts, have to appear before the Admission Committee on 28<sup>th</sup> November, 2022 at 09:30 A.M. with the required documents and fees of **Rs.20,000/-** (in form of Demand Draft in favour of IGNOU payable at Lucknow) for verification and admission.

2. All the candidates of Confirmed and Waiting List, who lives in cities far from Lucknow may send their **Coloured Scanned Copies / Photos** of all their required documents for Admission along with their photo & signature by post to the Regional Centre at the given address:

**Please note the following:**

- a) This letter is not to be treated as your admission letter. It is being specifically highlighted that candidates more than the number of seats available are being called for counseling. Therefore all the candidates called for the Admission Counseling may not necessarily get admission and IGNOU shall in no way be responsible for the same.
- b) During the counseling session, the seat will be offered to you purely on Merit List and available vacancy.
- c) The choice once accepted by the candidate will be final and not negotiable.
- d) The fee shall not be refunded under any circumstances after confirmation of admission.
- e) IGNOU will not be responsible for any postal delay and if you fail to attend counseling on the date and time stated above, you will not be considered with later batches (if any).
- f) Candidate of Lucknow and nearby districts may appear physically before the committee and candidates of farther districts may send their documents by post and by e-mail.
- g) The admission committee at the Regional Centre will examine / verify the e-mailed documents and confirmed the admission if the documents are found to be in order. In case of any deficiency the candidate can be asked to sent additional documents or remove/clear the deficiencies

Kindly note that every Certificates/Documents sought above is required to be produced for verification during counseling without which no counseling would be conducted. Further the candidates will have no right to ask any further dates for counseling.

**This offer of admission is provisional and is based on the documents in respect of qualification and other eligible criteria submitted by you along with the application form. If at a later stage, it is found that the document(s) submitted by you is/are false, your admission shall stand cancelled forthwith and no fee refund will be admissible in the event of such cancellation of admission.**

**Please note : Income Certificate is a must for determining OBC (Non-Creamy Layer Status). The Income Certificate should be issued by District Magistrate or Additional District Magistrate, Collector or Dy. Commissioner, Revenue Officer not below the rank of Tehsildar, SDO of the area as prescribed in the statues shall be valid.**
