B.Sc. (N) ADMISSION 2022 COUNSELLING SCHEDULE

On the basis of the entrance test held on July-2022 and the Merit drawn from applicants of Regional Centre, Lucknow. On 28th November 2022, the 1st Round of Admission Counselling the BSCN (PB) at Regional Centre and 29 seats are filled, with applicants fulfilling the eligibility criteria.

After 1st Round of Admission Counseling 1 seat of General Category and 3 EWS seats were remain vacant to fill in the vacant seats 2nd Round of Admission is schedule to be held on 4th January 2023.

1. All the candidates of Confirmed and Waiting List, who live in Lucknow and nearby districts, have to appear before the Admission Committee on 28th November, 2022 at 09:30 A.M. with the required documents and fees of **Rs.20,000/-** (in form of Demand Draft in favour of IGNOU payable at Lucknow) for verification and admission.

The above merit list is purely provisional and the cut-off merit of other categories may change depending upon the admission confirmation in General category. Since there is tie of marks, more number of candidates has been called for the admission counselling and admission will be given after resolving the tie cases of similar marks obtained in Entrance Test. No female candidate in Category War-Widow and no candidate in category Kashmiri Migrant have qualified.

Mere qualifying the exams will not grant any right for admissions, the candidates have to produce / forward the required documents & certificates of eligibility as mentioned in the B.Sc.(N) Prospectus-2022 and the offer letter before the Admission Committee. The candidate has to produce all

required documents as mentioned in the Offer Letter. Without these documents, the candidature will not be considered. In case the candidates fail to produce the required documents, their claim of admission will not be entertained and the seat may be filled by the next candidate in order of merit.

The category wise Confirm Merit/Waiting list will be available on IGNOU website i.e. www.rclucknow.ignou.ac.in SMS Alerts are also been sent to the candidates and the candidates are required to match the details along with the hard copy sent to them.
